

Authorizing the Executive Director to Terminate Select Section 8 Vouchers In the Event the U.S. Department of Housing and Urban Development (HUD)

Does Not Provide the Housing Assistance Payment Funding

Required to Meet the Financial Needs of the Existing Vouchers

WHEREAS, The Salem Housing Authority (SHA), a public body created and organized pursuant to and in accordance with the provisions of the Laws of the State of New Jersey desires to continue managing its Section 8 Program as long as HUD continues to provide the necessary Housing Assistance Payments (HAP) needed to fund the program;

WHEREAS, the SHA's current HAP commitment is \$19,761/month.

WHEREAS, HUD has reduced its HAP funding to the SHA down to \$17,275/month leaving the SHA with a funding deficit.

WHEREAS, the SHA will have applied its entire surplus of Net Restricted Assets to prior period funding shortfalls by June 1, 2013.

WHEREAS, the SHA is projected to have HAP funding shortfall by July 1, 2013.

WHEREAS, the SHA has attempted to mitigate its monthly HAP shortfalls through established Section 8 Program guidelines and through the methods outlined in HUD's PIH Notice 2011-28.

WHEREAS, the SHA has requested frontload and emergency funding from HUD to cover all of its projected HAP shortfalls.

WHEREAS, the SHA will need to terminate some of its existing vouchers if HUD does not provide the requested frontload and emergency funding.

WHEREAS, federal regulations provide that "The PHA may terminate the HAP contract if the PHA determines, in accordance with HUD requirements, that funding under the consolidated ACC is insufficient to support continued assistance for families in the program. 24 CFR, section § 982.454.

WHERAS, the SHA, in keeping with 24 CFR, Section § 982.454, has determined that funding under the consolidated ACC is insufficient to support continued assistance for families in the program.

WHEREAS, the SHA has carefully considered all cost-savings measures and the impact such terminations will likely have on program applicants and participants.

WHEREAS, despite the fact that certain SHA voucher holders were issued to tenants outside of the City of Salem, the intent of the SHA's section 8 program was, and still is, to serve residents of the City of Salem.

NOW THEREFORE, BE IT RESOLVED BY THE Board of Commissioners of the Salem Housing Authority that the Executive Director is authorized to terminate Section 8 vouchers in such quantity to offset any shortfall in HUD HAP funding IF, AND ONLY IF, HUD does not provide the requested emergency funding.

In selecting vouchers for termination, the Executive Director will start with the oldest vouchers issued to residents residing outside the City of Salem, NJ.





GENERAL TERMS

OUR RIGHTS & RESPONSIBILITIES

Service under this Agreement is dependent upon your meeting our credit requirements; necessary approvals of your state regulatory commission; and New Jersey Board of Public Utilities (BPU) and your LDC's continuing approval for you to have the right to make third party purchases of electricity from electricity service providers like South Jersey Energy Company

We warrant that the electricity will meet the quality standards of all utilities who are transmission providers and that title to such electricity will be free from all liens and adverse claims. WE EXPRESSLY DISCLAIM ANY OTHER WARRANTY OR REPRESENTATION, WHETHER WRITTEN OR ORAL, EXPRESS OR IMPLIED, INCLUDING THOSE WITH RESPECT TO CONFORMITY OF THE ELECTRICITY TO MODELS OR SAMPLES, MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE.

We will pay applicable taxes imposed on the electricity prior to our delivery to your LDC at the delivery point into your LDC's own distribution system.

We are not a party to your service agreement with your LDC and we do not assume any liability for your obligation to pay your LDC Charges.

We may transfer this Agreement, in whole or in part, to an affiliate, without your consent, or to any other third party, with your consent, which you will not unreasonably withhold. In the event there is a change in law, administrative regulation, tariff or any fees or costs imposed by the applicable ISO/RTO or by a Governmental Authority or a change in application or interpretation thereof, and such change causes SJE to incur any capital, operating or other costs relating to the provision of services contemplated herein, then to maintain the same level and quantity of Electric Power Supply Services, SJE shall have the right to adjust the amounts payable by Purchaser under this Agreement to reflect, based on the type of change, Purchaser's pro rata share of SIE's incremental costs resulting from such change. In the event, however, that such a change in law renders performance under this Agreement illegal, the Parties shall meet as soon as is practicable to attempt to renegotiate this Agreement to comply with such change. If the Parties are nevertheless unable to amend this Agreement, the Parties' obligations hereunder shall terminate upon the earlier of the date that the change in law becomes effective or the date that Purchaser commences service with a retail energy provider in lieu of SJE.

We may terminate this Agreement if you experience, in our opinion, a material adverse change in your credit, financial situation or ongoing business activities.

We are providing 100% installed capacity and energy in compliance with your LDC's retail access plan. Should the LDC's tariff or the ISO require us to provide additional services, including but not limited to, losses or ancillary services, we reserve the right to increase our price to you by the cost any such new requirement imposes on us.

We may, in addition to seeking damages for any breach, terminate your service on a minimum of thirty (30) business days notice to you and to the local LDC, if you fail to timely pay any amount due, fail to provide any required financial assurance or otherwise fail to fully comply with the terms and conditions of this Agreement.

We may be contacted, toll free, by calling 1-800-266-6020 from 8:00 AM to 4:30 PM ET or have a South Jersey Energy Company representative visit you, depending on the nature of the complaint or by writing to: South Jersey Energy Company, 1 South Jersey Plaza, New Jersey 08037. Our New Jersey electric license number is ESL-0012. The NJBPU's toll free number is 1-800-624-0241.

YOUR RIGHTS AND RESPONSIBILITIES

You hereby appoint us as your exclusive limited Agent and attorneyin-fact, in accordance with the terms of this Agreement, and authorize us to: make nominations; execute required documents necessary for us to provide service to you or on your behalf, aggregate your electricity supply, schedule, balance, make settlement, and bundle, whichever is applicable, with those of our other customers and to perform all other tasks appropriate to provide service to you.

YOU AUTHORIZE US TO USE YOUR NAME IN OUR CUSTOMER LISTS AS WELL AS OUR OTHER PROMOTIONAL MATERIALS.

You will promptly advise us of any change that constitutes a Material Change.

You are responsible for and indemnify us against any and all (a) Penalties or losses resulting from your failure to advise us of a Material Change or your failure to fully comply with this Agreement and (b) against any and all damage or injury caused by the electricity after our delivery of such to your Facility.

You will provide us as soon as practicable but no later than 24 hours with copies of any emergency or similar notices you receive from your LDC, by facsimile or by telephone contact, and will indemnify us from any costs associated with your failure to strictly comply with these orders/notices within the time prescribed.

You will pay us all amounts by the due date indicated and in the manner directed on our invoice.

You represent that all information you supplied is correct and that you are validly existing, financially able to continue your business, unaware of any situation which would alter your financial abilities and have not filed, planned to file or have had filed any bankruptcy proceeding. You will provide those financial assurances we deem reasonable to ensure your full performance.

You will (a) pay accrued interest on past due amounts form the due date at the rate of prime plus two percent; (b) pay non-sufficient funds charges on all returned checks at the rate charged by the bank where the account is held; and (c) reimburse us for any and all fees we reasonably incur to collect any and all past due amounts.
